List of shareholders with at least 5% of the votes at the Ordinary Shareholder Meeting of MLP GROUP S.A. with its registered office in Pruszków

Body of the report:

The Management Board of MLP GROUP S.A. with its registered office in Pruszków ("MLPG") hereby announces that the shareholders attending the MLPG Ordinary Shareholder Meeting held on 25 June 2015 represented 15,498,539 votes. This means that 85.56% of MLPG's share capital divided into 18,113,255 shares, each of which carries the right to one vote, was represented at the Ordinary Shareholder Meeting.

The following is a list of shareholders with at least 5% of the votes at the MLPG Ordinary Shareholder Meeting held on 25 June 2015:

1. **CAJAMARCA HOLLAND B.V.** with its registered office in Delft, holding 10,319,842 votes representing 66.59% of the votes at the Meeting and 56.97% of the total number of votes.
2. **THESINGER Ltd.** with its registered office in Nicosia, holding 1,920,475 votes representing 12.39% of the votes at the Meeting and 10.60% of the total number of votes.
3. **GRACECUP TRADING Ltd.** with its registered office in Nicosia, holding 1,094,388 votes representing 7.06% of the votes at the Meeting and 6.04% of the total number of votes.
4. **MIRO B.V.** with its registered office in Delft, holding 1,004,955 votes representing 6.48% of the votes at the Meeting and 5.55% of the total number of votes.
